2. Eligibility Criteria: SNRC may request the successful bidder to provide details regarding past projects and references (contact name and phone, company name, location of planting project) from recent (after May 2013) successfully completed planting projects of similar scale. This includes a fall plant with hot lift stock, stands damaged by fire, danger tree assessors on the crew, planting supervisors familiar with helicopter use for crew and seedling transportation, and adequate crew to meet minimum daily production of 20,000 trees. SNRC may conduct such independent reference checks or verifications as are deemed necessary by it, to clarify, test, or verify the information and to confirm the suitability of the Bidder. If, in the opinion of SNRC, the statement fails to demonstrate that the Bidder is able to successfully complete the Contract, SNRC has the right to disqualify the Bidder and award the Contract to another bidder.
3. SNRC plans to provide planting units and stock sown as described in the schedules. Changes beyond SNRC's control may occur that reduce the planting stock available for delivery, change in the area of the planting units, and change in access.

Tender Price Schedule

A. Rate to provide all services as described for DCR program (Atluck/Artlish), to plant per tree, all species, all stock types. This rate includes the cost of transporting stock from Arbutus Grove Nursery, storing in a reefer on site, and planting one 20g fertilizer tea bag per tree in a separate hole. Fertilizer is supplied at no cost. This rate does not include GST.
